Terms and Policies:

- I. Booking: This contract states the minimum number of people receiving services. If more persons are interested in services, please inform the artist as soon as possible. If the additional party members materially alter the original contract, a new contract could be required. Day of additions: we would love to add people if time allows, but decision will be at the sole discretion of the artist the day of event. Artist is under no obligation to provide additional services not listed in contract.

- II. Photographs: The client understands that any photographs taken during their trial run or on the event day may be used for promotional purposes, unless otherwise discussed with the artist.
- III. Cancellation Fee: No refund on deposit.
- IV. Stipulation: Captivating-Beauty reserves the right to pull out of this agreement if treated with extreme rudeness, or if put in a volatile situation that makes it difficult to complete the services.
- V. Miscellaneous: If the artist cannot perform the agreed upon services due to unforeseen circumstances beyond her control on the event day, 100% of all payments shall be returned to the client with the understanding that there will be no liability with respect to the agreement.
- VI. Trial Run payment is due at the time of the trial run and will be deducted from final balance since our artists do not collect money. We will send out an invoice for the trial run.
- VII. Credit Card number will be retained on file for/if additional services are added on wedding day.
- VIII. Delayed starting time and/or gaps between services will result in an additional service charge.
- IX. Refunds will not be given for services contracted. Services can be refused the day of the event, however the final bill will reflect the agreed upon total listed on contract.
- X. Our stylists are professionals and know the minimum time needed to complete the services. If the bride does not agree with our start time we are not responsible if the schedule gets behind. Please be flexible. We are diligent with our scheduling and time management to avoid stress the day of.
